## **RIGHTS ISSUE FULLY SUBSCRIBED**

Thundelarra is pleased to advise that the Renounceable Rights Issue announced to the market last month has been fully subscribed raising \$2.705 million.

The successful fund raising will enable the Company maintain a significant level of field activity at its key projects. A particular area of focus for the Company in 2009 will be the Pine Creek region of the Northern Territory where drilling at the Thunderball prospect in late 2008 intersected high grade uranium.

With the monsoon season coming to an end the Company is preparing for follow up drilling at Thunderball and first drill testing of Thunderball Extended where channel sampling undertaken earlier this year near the centre of a strong ground radiometric anomaly produced high grade uranium assays.

Securities issued through the rights issue were entered into uncertificated holdings and holding statements were dispatched on 25 March 2009.

An additional 28,478,852 ordinary fully paid shares and 9,493,080 options with an exercise price of 20 cents and expiry date 29 March 2013 have been quoted on the ASX.

A list of the 20 largest holders of the securities and the number and percentage of securities held by those holders is attached.

The Directors are very pleased with the high level of support for the rights issue and wish to thank shareholders who participated.
